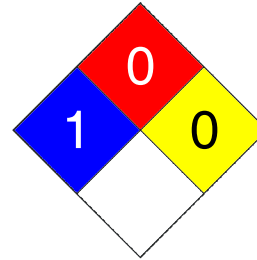

## 2. Hazards Identification

**Emergency overview** CAUTION  
 EYE IRRITANT. Skin irritation possible with prolonged exposure.

**First aid procedures**

**Eye contact** Flush with cool water. Remove contact lenses, if applicable, and continue flushing. Obtain medical attention if irritation persists.
